

OFFICIAL RULES. NO PURCHASE/POINTS NECESSARY TO ENTER THE SWEEPSTAKES.

A PURCHASE/POINTS DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1) **Sweepstakes Timing:** The Diapers and Wipes Sweepstakes (the “**Sweepstakes**”) begins 12:00 a.m. Eastern Time (“**ET**”) on 7/1/2018 and ends at 11:59 p.m. ET on 6/30/2019 (the “**Sweepstakes Period**”). The Sweepstakes Period consists of twelve (12) monthly entry periods as defined in the chart below in Rule #3 (each a “**Monthly Entry Period**”). The Monthly Entry periods will begin at 12:00 a.m. ET and end at 11:59 p.m. ET on the dates specified in the chart in Rule #3.
- 2) **Eligibility:** The Sweepstakes is open only to legal residents of the 50 states of the United States, the District of Columbia who are 18 years of age or older as of the last day of the month prior to date of entry and Canada (excluding Quebec) who are 19 years old or older as of the last day of the month prior to the date of entry. Employees of The Procter & Gamble Distributing, LLC (the “**Sponsor**”), Don Jagoda Associates, Inc. (“**Administrator**”) their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win.  - a) **TO ENTER BY REDEEMING PAMPERS REWARDS POINTS:** Pampers Rewards codes are available inside packages of Pampers Diapers, Pampers Training Pants and Pampers Baby Wipes. To join the Pampers Rewards program and for the complete list of Pampers products that contain Pampers Rewards codes and the corresponding Pampers Rewards Points, U.S. residents may visit www.pampers.com and Canadian residents may visit www.pampers.ca (the “**Websites**”). To enter the Sweepstakes by redeeming Pampers Rewards Points, during the Sweepstakes Period, you must first visit the Pampers app and log in and enter your Pampers Rewards code(s). The Pampers app can be downloaded from the Apple store or Google Play. Once you successfully enter your Rewards code(s) and the Rewards Points are credited to your Pampers Rewards account, you can redeem some or all of your Rewards Points on the app or Websites to enter the Sweepstakes. You must redeem twenty (20) Rewards Points to receive one entry into the Sweepstakes. There is no limit on how many Sweepstakes entries you can receive during the Monthly Entry Period by redeeming your online Rewards Points, but all online Sweepstakes Reward Point entries must be received by the date and time specified in the chart below.

- 5) **Sweepstakes Drawings:** One (1) Grand Prize winner will be selected each month in random drawings on or about the dates specified in the chart in Rule #3 from among all eligible entries received during the applicable Monthly Entry Period. The drawings will be conducted by Don Jagoda Associates, Inc. (at their offices in Melville, NY), an independent judging organization whose decisions are final on all matters relating to the Sweepstakes. Odds of winning are dependent upon the total number of eligible entries received during each Monthly Entry Period. Winners are responsible for all applicable federal, state, local and provincial taxes and all other costs and expenses associated with their prize not specified herein as being awarded.
- 6) **Winner Notification/Prize Redemption:** Potential winners will be notified by email on or about the drawing date specified in the chart in Rule #3. The Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or Websites; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. **Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes or Websites may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.** Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. You agree that: (a) any and all disputes, claims and causes of action arising out of, or connected with the Sweepstakes or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Ohio in the United States; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorney's fees; and (c) notwithstanding the foregoing, you waive the right to claim any damages, whatsoever, including, but not limited to, punitive, consequential, direct or indirect damages.
